This agreement is made, and hereby entered into by and between MythNMagic (hereafter referred to as "Seller"), and <<Names>> (hereafter referred to as "Purchaser"), for the purpose of setting forth the terms and conditions of the purchase by the Purchaser of a Golden Retriever.

Puppy will have a minimum of 3 deworming treatments; 8-week vaccinations; microchip; one month Trupanion Pet Insurance; Puppy Transition Kit (food, toys, treats, blanket, parasite protection (applied before departure); CKC registration papers (mailed 6 months of age). Everything for your new puppy to transition into their new family.

This is a legally binding contract with the purpose of protecting the Seller, Purchaser and the puppy. Should you, the Purchaser, at any time prior to taking possession of your puppy change your mind it shall be understood that any deposit paid is non refundable. As breeders, it is our hope that you will take exceptional care of this puppy throughout its entire life. This means providing socialization, medical, proper nutritional, physical needs as necessary, treating your Golden Retriever as part of your family, and giving it lots of love for the remainder of its life. If for any reason you are unable to keep this puppy please contact us first. We will always accept one of our offspring back. We do not repurchase or "buy back" dogs unless under the terms of our "right to first refusal" clause contained herein. Remember that environment and how it has been raised has tremendous impact on how the dog will turn out. Purchaser agrees that this puppy will receive obedience training beginning at approximately 4 months of age.

Seller certifies that said puppy is in good health to the best of Seller's knowledge. The purchaser is strongly advised to have the puppy vet checked within three days of collecting the puppy. If upon examination the veterinarian finds that said puppy is not in good health, the Purchaser must notify the Seller within 24 hours. Purchaser shall return the puppy to the Seller with all of the veterinarian documentation. Seller shall replace said puppy with another puppy of equal value as soon as one is available.

The Purchaser agrees that any and all transportation at any and all times, to and/or from the Seller's premises, will be at the cost and sole responsibility of the Purchaser. The seller is not responsible for any veterinary fees once dog/puppy has left Seller's premises. No reimbursements for veterinary care will be made by seller to Purchaser. The Purchaser agrees to maintain preventative health care of the puppy including, but not limited to: vaccinations, internal and external parasite prevention and/or treatment and heart worm preventative medication if travelling to areas needed. The Purchaser agrees to maintain preventative care of the puppy in regards to hip dysplasia, such as proper nutrition, proper exercise, and preventing stress injuries (ie. Not allowing the puppy to jump from heights taller than itself at the shoulder, no forced exercise etc.) The Purchaser also agrees to keep the Puppy on the diet that the Seller has raised the litter on until a minimum of six months of age. Changes to the diet can disrupt the digestive tract and cause long-term issues with gut flora and digestion. Absolutely no grain free diets can be fed to this puppy/dog during its life.

This puppy is being placed as a pet only and purchaser agrees to spay/neuter their pet when appropriate for the dog. Females may be spayed after 12 months of age and males may be neutered after 14 months, preferably after 18 months of age. Spay or neuter before these ages voids all hip guarantees on puppy.

The Seller has enquired of the purchaser his or her past experience with dogs and with this particular dog breed and on the basis of the information received is willing to place a puppy with the purchaser. The Seller will instruct the purchaser of the main conditions the breed is prone to and the health schemes followed to reduce the risk of such conditions. The Seller guarantees that said puppy will be free of genetic eye disorders and crippling hip dysplasia for 14 months. Any puppy unable to function as a household pet due to canine hip dysplasia must be diagnosed as such by an OFA board-certified veterinary radiologist. Buyer must present all documentation along with x-rays, proof of preventative health care, this contract, and puppy/dog to the Seller. When a puppy of equal value is available, replacement shall be made. No refunds will be offered. Every puppy is an individual and the breeder cannot be held responsible should conditions develop later in life.

This agreement is made by both parties to ensure the well being and protection of this animal. If any part of this agreement is breached, the Seller is released from any further obligation hereunder. Should the Seller need to seek legal action against the Purchaser for violations of this agreement, the Purchaser will assume any and all legal costs and court fees. This contract must be presented to Seller for any guarantee of any kind to be in effect.

The Purchaser agrees that he/she is not acting as or in part of an agent in the purchase of this puppy and that the Purchaser will not sell this puppy or any of it's progeny to any agent, pet store, or guard dog business. The Purchaser agrees that should it become necessary to place this puppy/dog, the Purchaser will notify the Seller in writing by certified mail before taking such action so that the puppy/dog may, at the Seller's option, be taken back by the Seller. Purchaser is responsible for all shipping charges. Upon receipt of notification, the Seller shall have 21 working days to exercise said option. Exercise shall be notice in writing (to include, but not limited to email) sent to the Purchaser. The Purchaser agrees that the Seller may repossess the animal upon evidence of neglect and/or abuse at no expense to the Seller, and no refund and any monies. Said neglect shall be determined in accordance with the laws within the Purchasers county of residence. The Purchaser agrees that the puppy will reside at the home of the Purchaser, and not be chained or "tied out". This animal is sold with the understanding that it was to go to select homes, be socialized properly, and become a member of the family. Purchaser agrees to release and hold harmless Seller for any and all liability, damages, or injuries, caused either directly or indirectly by Puppy to any person, animal, whether actual or legal, or to any property whether real or personal. Furthermore, Purchaser assumes full liability for any damages or injuries, whether physical or mental, emotional or economic, caused by puppy, to any person whether actual or legal, or to any property, whether real or personal, after taking possession of puppy.

This contract shall be deemed a legal and binding agreement between Seller and Purchaser and is under the jurisdiction of the province of British Columbia. It is further agreed that should any dispute/arbitration between Seller and Purchaser regarding said puppy/dog occur that the legal venue shall be the city of Nanaimo, province of British Columbia. I/We the Purchaser, certify that I/We have read the foregoing contract, understand its contents and I/We hereby agree. We understand that deposits are non-refundable.
